

**“Transitions® VisionNEXT” Sweepstakes  
OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW. NOT OPEN TO THE GENERAL PUBLIC. MUST BE PRESENT TO WIN.**

**SWEEPSTAKES DATES:** The “Transitions® VisionNEXT” Sweepstakes begins on March 24, 2026 and ends on May 12, 2026 (the “Sweepstakes”), subject to dates and times of Transitions® VisionNEXT Events as outlined in the “HOW TO ENTER” section of these Official Rules.

Any attempt by an Entrant to obtain more than the stated number of entries by using multiple/different identities, and/or any other methods will void that Entrant's entry and that Entrant may be disqualified from the Sweepstakes.
